## INDIANA AAUW WEB SITE CELEBRATES 10 YEARS



On July 1, 1999, following a 60-minute training session and a request to host the site at Indiana State University, the Indiana AAUW web site was born. Located at <http://www.indstate.edu/aauw-in/home.html>, it provides Indiana AAUW members with links to information about Indiana Branches and State Officers. It has provided access to Education Foundation sale items, currently offering the great new bags that were introduced at the April State Convention. Also during the State Convention, I videotaped and uploaded Indiana President Barb Kanning's start of the business meeting, and the afternoon awarding of Branch Recognition certificates by Phyllis Thompson. We have also linked to or announced special events by individual branches. Each branch has its own page containing the following basic information: Year formed, amount of dues, and number of members. The branch member numbers were just updated, based upon the February member counts from National. If a branch has its own web site, there is a link, not only on the web site's

main page, but also on the branch page. Currently, Fort Wayne, Valparaiso, and Muncie have their own sites. At the top of each page on the web site, you will see an email link to [aauw.indiana@yahoo.com](mailto:aauw.indiana@yahoo.com). That's me as well, but provides a standard email link that others can access. If you need to submit ANY information related to your branch, or need to make a correction/update or suggestion, use that email address. I do not check it every day but do check it once a week or so. The Events & Announcements link <http://www.indstate.edu/aauw-in/home.html#EVENTS> is a good one to keep in mind. If you have not already done so, on your own computer, you might like to set up an AAUW Favorites folder and then set a bookmark for at least the homepage [above], your branch, and the State Officers page at <http://web.indstate.edu/aauw-in/officerpages.html>. # INDIANA SCHOLARSHIP WINNERS IN ATTENDANCE AT NCCWSL, June 4—6, 2009, University of Maryland

The State Board is pleased to announce that two scholarships of \$300 each were awarded to two Franklin College students to attend the recent National Conference for College Women Student Leaders (NCCWSL) at the University of Maryland, College Park. Here is an introduction to each of these outstanding recipients:

**Elizabeth Kuka**—Elizabeth just completed her sophomore year at Franklin College. She is majoring in Spanish with minors in leadership and psychology, and she holds a nearly perfect grade-point-average. She has been on the college's Student Congress for two years, one year as a class representative and this past year as chairwoman of the Academic Affairs Committee. She works in the Office of Admissions on campus and gives prospective students tours, meets with families, and gives group presentations. Elizabeth is currently the secretary for a new organization specifically designed to advocate for high school Latinos. Her career goal is to work with minority populations in the U.S., specifically targeting younger Latino students.

**Megan Mattingly**—Megan, who just completed her sophomore year at Franklin, also has a very high GPA. Her majors

are Spanish and public relations with a minor in leadership. She, too, has served on the Student Congress for two years, first as a class representative and this past year as secretary. She was invited to attend Board of Trustees meetings and to relay information back to the student government. Like Elizabeth, she has been chosen as a mentor for new students on campus. She is also a cheerleader, and she serves on the Student Entertainment Board. Megan's career goal is to be a public relations professional for a sports team or player. She would also like to do publicity for a Hispanic nonprofit organization.

Both of these young women have agreed to speak about their experiences at NCCWSL if asked by AAUW

branches. Also, I want you know that Professor Kathy Carlson, C/U representative for Franklin College, was very helpful in identifying Elizabeth and Megan as potential scholarship recipients. This shows one of the important ways that we can interact with colleges and universities. Please look for such opportunities in the institutions of higher education in your area of the state.

## Legal Advocacy Fund

### A Matter of Justice

The AAUW Legal Advocacy Fund is alive and well. It still needs all of its members to contribute and to communicate its objectives and programs.

To be more specific, AAUW Legal Advocacy Fund provides financial and moral support for those fighting sex discrimination in the workplace and on campus; develops and supports proactive Campus Outreach Programs, produces comprehensive online legal resources, sustains a network of attorneys, advocates for equitable policies and practices for campuses and workplaces. In other words the AAUW Legal Advocacy Fund breaks through barriers so that all women have a fair chance.

### New Initiatives

LAF is crafting a manual and Program in a Box focused on campus sexual assault policies in collaboration with the AAUW Research Department, Harvard University Law Professor and Title IX expert Diane Rosenfeld, her students

and Students Active for Ending Rape. These materials will educate individuals about Title IX sexual assault compliance requirements, provide them with tools to help ensure sexual assault policy enforcement, and give them programming ideas on prevention and enforcement. The materials will be released in September 2009.

In collaboration with the AAUW research Department and Legal Aid Society of San Francisco, LAF plans to release a new tool kit and Program in a Box in the fall on Title IX enforcement in high school athletics. These materials will focus on the rights of girl athletes and how schools can and should be approached to ensure title IX implementation and enforcement.

## E-STUDENT AFFILIATES

Then, in addition, they receive 1 free year of membership under the "Give a Grad a Gift" membership. Every College/University institutional member of AAUW has a person designated as a representative. Some of these representatives are AAUW members and are actively involved in AAUW; some are not. Therefore, it is unclear how much information has been shared on each campus. In late April, I followed up on the other students whose names had been submitted back in November. I asked them if they remembered getting an invitation and if they would like to receive it again. Several emailed back that they would. I asked Ms. Noe for a copy of the email message that National sent her, and, quite frankly, was a bit disappointed. First of all, the Subject line was a bit indirect. And the information could have been put together a bit better. I think I would like to suggest to National C/U, that they give each person, such as myself, a copy of their template, with the links needed to reply/join, but then allow us to tailor the message, with the idea that a local student, getting a message from a local contact, might respond more readily. I am not aware of how the program is working elsewhere, but I think, overall, it is the best attempt to get the undergraduate students to join, and to stay joined, with AAUW. But it is something that each College/University representative needs to be very proactive in pursuing. It is also important that ANY AAUW member who knows a person currently in an Indiana AAUW member institution or any other state's AAUW institutional members, get in touch 1) with that student and 2) with the C/U representative, to get the student included in the process. ## Public Policy Report

Hello fellow AAUW members! I was pleased to be installed as the Director of Public Policy on the Indiana AAUW Board of Directors at the April state meeting in Warsaw and am really looking forward to this coming year. I first became involved with AAUW several years ago when I was the Director of the Indiana Commission for Women. Mitzi Witchger and Coy Halpern literally reeled me in and I was hooked! I belong to several other groups but at my first meeting at AAUW, when I heard women discussing books, plays, current events – and even politics! – I knew I was in the right place with the right group of women!

I am a graduate of Indiana University and have spent most of my career in public service with state government. I am currently with the Indiana Criminal Justice Institute which is the state's planning agency for criminal justice, juvenile justice, traffic safety, and victim services. I work in the area of domestic violence and sexual assault and am working on a project to develop a professional certification standards program for victim advocates.

Prior to coming to ICJI, I served as the Executive Director of the Indiana Commission for Women for three years and prior to that spent a number of years working with displaced workers as the Director of the Indiana Workforce Development's Workforce Transition Unit. I find that the chapters in my career have all fallen nicely into place, from workforce development (jobs and job loss) to issues impacting all women which then led to a focus on the area of violence against women.

On a personal note, I have been married many years to a wonderful man (Lee) and we have two daughters, ages 22 and 27. In my speaker's bio I always include the statement "*during the girl's teen years Sharon gained valuable skills in crisis management, high drama, and fiscal disbursement that could make a corporate controller weak in the knees*". I am sure most of you can relate to that!

As you all know the national convention is coming up June 26 – 28 in St. Louis. Delegates will be voting on some major changes in the bylaws and Public Policy program. 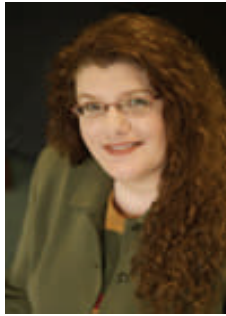

## Support the Paycheck Fairness Act

### AAUW Marks 46th Anniversary of Equal Pay Act with an Appeal to Senators Urges Lawmakers to Move the Paycheck Fairness Act Forward

WASHINGTON – On the 46th anniversary of the signing of the Equal Pay Act, AAUW urges lawmakers to make real progress on closing the wage gap between men and women by passing the Paycheck Fairness Act (S. 182).

Signed into law by President John F. Kennedy on June 10, 1963, the Equal Pay Act prohibits gender-based pay discrimination, but the wage gap remains stubbornly in place. The Paycheck Fairness Act would strengthen the Equal Pay Act by taking meaningful steps to empower women to negotiate for equal pay, to create strong incentives for employers to follow the law, and to strengthen federal outreach and enforcement efforts.

"It's time the Equal Pay Act lives up to its promise to provide equal pay for equal work," said AAUW Executive Director Linda D. Hallman, CAE. "In 1963, women made just 59 cents on the dollar compared to their male counterparts. Nearly 50 years later, that figure has climbed at a painfully slow pace to just 78 cents on the dollar. Women should not have to face pay discrimination at work, especially during these tough times."

As the recession continues, women are increasingly becoming the sole breadwinners in their families — making pay equity not just a matter of fairness but the key to a family's ability to make ends meet.

"The Paycheck Fairness Act closes serious loopholes that have developed in the Equal Pay Act over the years," said Lisa Maatz, AAUW director of public policy and government relations. "With a strong bipartisan vote in the House in January and 31 cosponsors in the Senate, AAUW members across the nation are working hard to put this bill on the president's desk."

Thanks to the hard work of AAUW and our coalition partners, President Barack Obama signed the Lilly Ledbetter Fair Pay Act into law in January, sending a strong message that economic issues and pay equity are a top priority. The Lilly Ledbetter Fair Pay Act restores basic protections that allow workers to challenge wage discrimination, but it's only the first step to fair pay. The Paycheck Fairness Act, along with the Lilly Ledbetter Fair Pay Act, will help create a climate in which pay discrimination is not tolerated.

Ledbetter herself is a strong supporter of the Paycheck Fairness Act. Although she spent years of her life on a case that will never yield her a dime, she often says that helping working women is her reward. She will speak at the AAUW National Convention in St. Louis, June 26–28, where members will have the opportunity to attend a variety of workshops, including several focused on public policy and advocacy.
